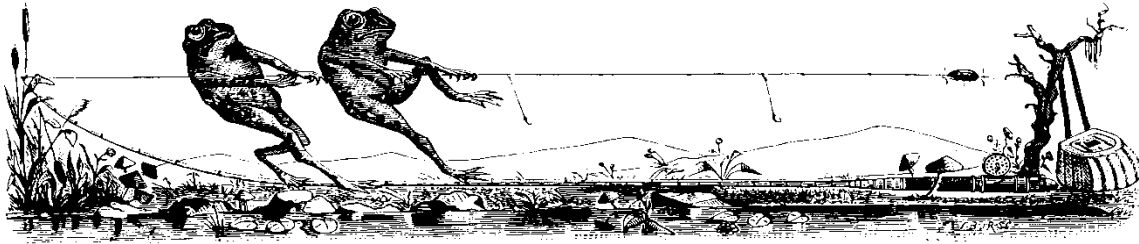


2010 NFLCC NATIONAL SHOW & MEETING

MEET RESTRICTIONS: You must be a member in good standing with the NFLCC, meaning all dues paid through June 2011, in order to attend the show. Only fishing tackle and related items will be permitted in the exhibit hall, either for display, sale, or trade. **ABSOLUTELY NO EXCEPTIONS! DO NOT send membership dues renewal with your registration!**

REGISTRATION & TABLES: Advance show registration is \$25.00 per member which includes spouse and children. Each paid member is allowed to bring one (1) non-NFLCC guest free of charge. Additional guests must purchase a membership and registration. Pre-registration will close on June 27, 2010. No refunds after June 11, 2010. **A postcard or email confirmation will only be sent to registrations that specifically request one.** Registration at the door will be \$30.00 per member, so register early. Table registration is \$25.00 per 8-ft table, and \$15 per table for special collection exhibit tables (free for youth exhibits). Tables will be assigned on a first come basis. Move in for exhibitors starts at 7:00 A.M. Thursday, non-exhibitors 9:00 A.M. Please note any special requests on your registration form. Members wishing to guarantee tables next to each other should send their separate forms and checks in the same envelope.
